

A win at the New Zealand Law Awards 2022

- Mid-market deal of the year - Sale of Rydges Wellington hotel to New Zealand Super Fund and NZ Hotels Holding Assets
- Insolvency and restructuring deal of the year - Indevin Group acquisition of Villa Maria Estate from FFWL receivership.

The sale of Sale of Rydges Wellington hotel to New Zealand Super Fund and NZ Hotels Holding Assets was the largest hotel sale in New Zealand in 2021, eclipsing the sale of the Sofitel Queenstown Hotel and Spa that Buddle Findlay acted on earlier in the year. Buddle Findlay is delighted to have acted for Hotel Management (Featherston St) (Hotel Management), as well as over 150 different unit owners, on the sale.
